





4.2) How could this module be improved?

- Could have speed up some of the contents on the day 1.
- His handwritten notes were bit hard to follow, but then again they made me pay more attention so not sure if it would be improvement or not..
- If the actual working of an IPO are important they should have not left to be done at the final hours of the last day. The explanation of the mechanism of the IPO were rushed as we were running out of time and the energy levels were at their lowest (this discussion started in the afternoon of the 4th day of classes).
If important should be planned not to be the final discussion of the module.
- More to the point
- Perhaps what we could have done would a little more practical examples to support the theory.
- The "handwriting"-based part could be maybe substituted with slides or anyway done in a slightly more structured /organised way for better understanding
- The lecture only covered half his course material as it was prepared for a 4 day Dubai course not a 2 day London course. that raises concerns for the exams as half the course material was not covered at all with the lecturer... the exam should reflect that gap.
- The time allocation can be better.
It will be useful to have an agenda for the 2 days as it will help with time management
